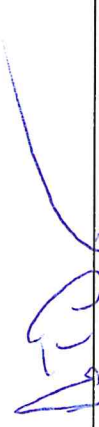

A RESOLUTION REQUESTING FINANCIAL ASSISTANCE

UNDER SEDAP - DELTA REGIONAL
AUTHORITY PROGRAM

WHEREAS, the State of Louisiana has announced that applications are being accepted for the States' Economic Development Assistance Program (SEDAP), funded by the Delta Regional Authority (DRA); and

WHEREAS, the States' Economic Development Assistance Program offers grants to eligible municipalities and parishes for a wide range of projects to build basic public infrastructure, build transportation infrastructure, promote business development with an emphasis on entrepreneurship, and promote workforce development; and

WHEREAS, it is deemed necessary and proper for the Town of Leonville to submit application(s) to the States' Economic Development Assistance Program; and

WHEREAS, the Town of Leonville hereby commits to a local match to fund all costs over the grant amount.
