Motion by Kirk Stelly, seconded by Kerry Willingham, all in favor to approve submission of application for Water Sector – Phase 2 funding.


Engineering Report was given.


Lance Lee, Town Manager gave report.

Ordinance #4 of 2024

An amendment to Ordinance #1 of 1985 of the Town Policies and Procedures Regulating the Employment of Municipal Employees.

BE IT ORDAINED by the Mayor and Town Council of the Town of Leonville, Louisiana, acting as the governing authority of the said town, that Ordinance #1 of 1985, referred to as An Ordinance Establishing Policies and Procedures Regulating the Employment of Municipal Employees which was adopted on December 17, 1985, is hereby amended as follows:

Employee Benefits:

The Town of Leonville provides the following benefits to all full-time employees:

- Health Insurance – Employer 75%/Employee 25%
- Vision Insurance – Employer 75%/Employee 25%
- Dental Insurance – Employer 75%/Employee 25%
- Life Insurance – Employer 100%
- Vacation/Annual/Sick Leave (Described under Leave Policy)
- Designated paid holidays (Described under Holidays)
